Course Description:

This course examines organizations and operations of U.S. legal system, legal rules and ethical constraints on business, and the practical applications of these rules. Students will gain knowledge of the legal process, administrative regulations, and liabilities of employment. Topics on securities, transactions and environmental law will be discussed as well. Students will develop analytical and problem-solving skills for decision-making in business.

Course Format and Requirements:

Class time will be used for a combination of lectures, class discussions, and student presentations.

Attendance:

Attendance at lectures is vital to get a thorough understanding of the material. This course requires verbal participation in class exercises, activities, and contributions to class discussions. Students must be present and actively involved to receive these points.

Quizzes will usually consist of True-False, multiple choices and short answer essay questions. 6 quizzes will be given and the lowest score will be dropped.

Exams:

Two midterms and a final will be given. Students are required to join all exams. Students will solve multiple choice questions, case analysis questions, short Q&A and in-class essay questions.

Articles Review

Prepare three recent news articles related to legal issues about business, write summary to



accompany each article (one page in length, single-spaced). The summary will describe topics including: (1) ethical issue presented in the article, (2) analyzing the issue applying the ethical principles covered in class, and (3) personal recommendation of how the issue should be solved.
